Pool/Playground/Open Grass Area Around Lodge Parties Are Restricted

The swimming pool is available for private pool parties with a cleaning fee on each Sunday from 6:00 pm until 10:00 pm. Pool parties are not allowed during pool hours. The swimming pool is for all homeowners to enjoy. This is not just a matter of HOA rules, after paying dues the homeowners feel they are unable to enjoy the property during a party violation. Also, keep in mind that it does not matter if every person attending a party is a Woodland Creek resident, a party is a violation and stops others from enjoying their amenities.

The playground or HOA open grass property <u>is not</u> available and not open to parties nor booking reservations. These are common areas for all homeowners to use. The patio is booked with the lodge booking only. Homeowners are unable to hold a private party on the patio at any time. SIGNS ON YOUR PROPERTY

Just a reminder that signs are not allowed in the Woodland Creek Covenants and Restrictions. <u>"11. SIGNS:</u> No sign of any kind or nature, or advertising device of any kind or nature, shall be placed upon any part of any lot owned by any person or entity except as permitted herein or in accordance with applicable ARC Guidelines."

You may not have been aware there were covenants and restrictions when purchasing in Woodland Creek, but they are one of the main reasons most people purchased. Homeowners have an expectation of their subdivision's appearance. When purchasing your beautiful home, if you had passed 100 signs in 100 yards before you reached your home, it could have made a difference. There are no lifeguards on duty.

Pool Managers are present, but we are not able to cover all time slots.

POOL PARTIES: The swimming pool is available for private parties on Sundays from 6:00 pm until 10:00 pm Pool Parties are \$150 Rental Fee

POOL RULES

- 1. Access to the pool area is by use of a keycard.
- 2. Swim at your own risk- No Lifeguards are on duty.
- 3. Children ages 13 and up that can swim the length of the pool may swim unaccompanied by an adult. These children may be asked by the Pool Manager, at any time, to demonstrate the ability to swim the length of the pool and provide proof of age. An adult 18 or older must accompany Members and guests of Members the age of 12 and under using the swimming pool. Children ages 8 -12 years old, that can swim the length of the pool, may swim unaccompanied as long as a parent or guardian is on the pool deck at all times. Children age 7 and under must be accompanied in the water by a parent or guardian at all times.
- 4. Users of the wading pool must be accompanied and supervised by an adult at all times.
- 5. Diving is not allowed.
- 6. Please shower before entering pool.
- 7. Pool hours will be posted and/or are available at the Information Center. Loitering at the pool for any reason other than sunbathing and swimming will not be permitted.
- 8. Profane language and shouting are prohibited. Public intoxication and/or disorderly conduct will not be tolerated. Running, shoving or rough play will not be allowed. No objects may be thrown in the pool or on the deck area.
- 9. Glass containers and bottles are not allowed in the pool area. Please help keep the pool deck clean and dispose of all trash.
- 10. Please use the Amenity Center restrooms for changing. Proper swimwear, as determined by Management, must be worn to enter the pool. Un-hemmed cut offs are not allowed. Bathing suits are not allowed inside the Amenity Center.
- 11. Children's disposable diapers are not allowed in the pool. Appropriate swimming diapers and plastic pants must be worn at all times.
- 12. The only flotation devices allowed in the pool area are as follows: water wings, swim vests, noodles, small blow up balls and baby swim rings. Floats and boogie boards are not allowed.
- 13. Return all pool furniture to a neat and orderly arrangement. Semi permanent pool furniture (i.e. picnic tables) should not be moved.
- 14. If the pool/wading pool deck or restrooms need attention, Members should notify the Pool Manager on duty or e-mail: dklein@lowdernewhomes.com.
- 15. Please be considerate of your neighbors.
- 16. The bather load is 140 persons for the main pool and 25 persons for the wading pool.
- 17. There is a strict no smoking policy for the pool area. Other tobacco uses are also prohibited.
- 18. Animals are not allowed on the pool deck unless use is for aid in disability.
- 19. Management reserves the right to adjust or add any rules as needed. Additional pool rules may be posted at the pool area or may be implemented without notice. Management reserves the right to refuse anyone the use of the pool and its facilities. Failure to adhere to these rules may cause the loss of pool privileges. The Pool guest policy may be revoked or changed at any time by Association Management.

POOL / WADING POOL WEATHER CLOSURES

- 1. The pool/wading pool may be closed at times due to inclement weather.
- 2. The pool/wading pool must be cleared immediately at the direction of management at the first sound of thunder or sight of lightning. Members and their guests will be told to keep a safe distance from the pool and from all objects that would endanger them from being electrocuted. Members or their guests, are not permitted to go near water, take showers, sit on picnic tables or use the telephone (except in the case of an emergency) until conditions permit.
- 3. Closure will be until thunder has not been heard and/or lightning has not been seen for at least 30 minutes.
- 4. Any condition that causes the vision of the bottom of the pool to be distorted is reason to close the pool. This includes raining (without lightning or thunder), increase in algae growth or chemical imbalance. Once the condition is cleared, re-entry will be allowed.

POOL / WADING POOL GUEST RULES

1. Each Member may have two (2) guests at any one time. All guests must be accompanied by a Member. Members are responsible for the actions of their guests. Guests are defined as anyone other than a Member of the Woodland Creek Homeowners' Association, Inc. Guests must follow the pool rules. Violation of this rule can result in the loss of pool/wading pool privileges.

The HOA has advertised the sale in the local area classified market and a banner will be placed at entrance to subdivision. The Spring Yard Sale has proven to bring in many buyers, so start your spring cleaning and get ready.

LAWN MAINTENANCE

The Woodland Creek HOA Covenants Committee considers the community standards of a "well maintained" yard to be:

- Routinely mowed (once per week in the heavy growing season);
- Yards fertilized and weed control on a routine basis; Yard maintenance is this
 neighborhood need some type of weed control. (Weeds grow faster than grass.)
- Sidewalks and driveways routinely edged;
- Grass and weeds in cracks in the sidewalks and driveways removed or killed by herbicide;
- Shrubbery neatly trimmed;
- Any part of the driveway visible from the street free from clutter;
- Dead grass and shrubbery removed and/or replaced.

Failure to comply with any or all the above community standards could result in a covenants violation.





TRASH CANS OUT OF SIGHT!

Please remember that trash cans must be off the street and out of sight after trash has been picked up.

The HOA sends out Neighborhood information and notices by email. Recently a Neighborhood email was sent out with the upcoming Neighborhood Calendar of Events. Please check your email (or junk mail) to verify you are receiving HOA emails. The email list is built from your New Resident Registration Form. Many times hand writing is not legible and email is incorrect.

Woodland Creek has grown in the number of homes and resales of existing homes have been unusually high. The subdivision has several hundred new residents.

Dog off Leash

Dogs are unable to run off leash in a Subdivision like Woodland Creek. It is understandable that some residents look at this area as being in the country, but in a Neighborhood like Woodland Creek dogs must always be on a leash. Over the last couple of years dog ownership has increased along with a number of incidents in the subdivision. Please obtain the street address of the dog's owner and notify the HOA office. A Covenant Violation letter is processed and documented in the owner's file.

- There are a number of residents that have contacted the HOA office because they have a fear of a dog running at large and are unable to walk freely on their own sidewalks.
- A dog off leash creates a nuisance and an unreasonable condition for the residents.
- Liability to the dog owner could prove to be financially substantial when a dog bite of the skin occurs to a person or another animal.

The Lodge Rental is only available to residents of Woodland Creek.


